A lot of proposals have been received from various Officer-in-charges of Regional and Sub-Offices of this Directorate for approval of the Head of Department for constitution of Local Purchase Committee (LPC) consisting of three members (Gazetted) for that office, as per Rule 155 of the General Financial Rules (GFR), 2017 for purchase of goods on the basis of the recommendations of a duly constituted Local Purchase Committee (LPC).

2. It has come to notice that the Officer-in-Charge of the concerned Office is proposing himself/herself to be nominated as a Chairman/Chairperson/Member in the Local Purchase Committee (LPC) for that Office. To ensure transparency and fair manner for Government procurement and avoid any anomaly, the Competent Authority of this Directorate has decided that the Regional-in-charge will submit a proposal to the Directorate seeking approval of the Head of Department for constitution of a Local Purchase Committee (LPC) for each offices under their jurisdiction. While submitting of the proposals, the Regional-in-charge will ensure that all the members of the proposed LPC should be from the local level (Gazetted Officers) irrespective of this Directorate and the Regional-in-charge will not nominate himself/herself as a Chairman/Chairperson in the LPC. In case the nomination of the Regional-in-charge is essential for LPC, they will submit the proposal through their Scheme-in-charge.

3. As regard constitution of LPC for RPTL, Chandigarh and Kanpur, the proposal will be submitted by the Scheme-in-charge of RPTLs (i.e. In-charge of TLC).
