Officer-in-charge/Station-in-charge may please refer the Dte.'s office memorandum dated 21.01.2019, on the subject mentioned above vide which this Dte has advised to the officer-in-charges for disposal of condemned vehicle(s) as per the Rule 218 to 221 of General Financial Rules 2017. In this connection, it is also informed that Dte. has conveyed the approval of DAC&FW for disposal of 22 vehicles of 16 CIPMCs, 34 vehicles of 08 LWO/LCOs and 03 vehicles of 03 PQs station but most of the stations have not initiated the process to auction condemned/pre-maturely condemned vehicle(s) even elapsed three-four months on receiving the approval.

A guideline vide Addendum No.1 bearing file No. 33011-29/2016-GA(Pt) dated 25.02.2019 has already been issued in this regard (copy enclosed). Therefore, it is again requested to initiate the steps immediately for auction of the vehicle(s) and a sale account should also be prepared in Form GFR-11 duly signed by the Officer-in-charge after completion of the auction and submit to the Dte. for information.
