Officer-in-charge/Station-in-charge who have received approval of the competent authority of DAC&FW for disposal of condemned/pre-maturely condemned vehicle(s) is requested to initiate the steps for auction of the vehicle(s) as per the Rule 218 to 221 of General Financial Rules 2017 and the guidelines circulated vide Dte. Office Memorandum bearing No. 33011/29/2016-GA(Pt) dated 02.01.2019.

It is to inform that Dte. has conveyed the approval of DAC&FW for disposal of 18 vehicles of 13 CIPMCs, 19 vehicles of 6 LWO/LCOs and 02 vehicles of 02 PQS station but most of the stations have not initiated the process of auction of their condemned/pre-maturely condemned vehicle(s), due to the reason, the vehicle(s) got deteriorate its value and office space has also be blocked.

Therefore, it is requested to initiate the steps immediately for auction of the vehicle(s) and a sale account should also be prepared in Form GFR-11 duly signed by the Officer-in-charge after completion of the auction and submit to the Dte. for information.
