The officers who have been transferred from their present place of posting to the new place of posting on administrative grounds will be entitled for Transfer TA, as per the Government Rules and Regulations. The officers, who have been transferred from their present place of posting to the new place of posting on their request, will not be entitled for Transfer TA. All officers are entitled for Joining Time as admissible under the Rules.

The above transfer/postings are ordered on the recommendations made by the Transfer Committee after due consideration of all requests, incumbency position, previous posting details and suitability/availability, administrative reasons and functional requirements, etc., and after disposing off all representations received till the meeting held on 28th August, 2020, in this regard.

5. The concerned officer-in-charge(s)/controlling officers are hereby directed to relieve the officers/officials under their jurisdiction, immediately. A copy of the joining/charge report may also be sent to this office, at the earliest.
