2. These Drivers will not be engaged for full time and will be engaged only for three/four hours daily/need basis, through an agency and at minimum wage as per rates of the labours Department of that State.
3. He/She will not claim for regular appointment. An affidavit to this effect will be furnished by the Driver before engaging him/her that he/she will not be entitled for regular appointment.
4. The Directorate is facing litigation from some of the part-time safaiwala/part time labours for their regularization in Government Service as they have been engaged by the Sub-offices for a very long time. To avoid such litigations the Officer-in-charge of the Sub-offices are, therefore, requested not to engage same person on part-time Driver for more than three months continuously in financial year.
5. Expenditure will be met from within sanctioned budget/funds provided for the purpose during the year which comes under the power of Head of Office.
