Subject: Observance of Vigilance Awareness Week from 27th October to 2nd November, 2020 – reg.

Officer-in-charges of all the Subordinate Offices of this Directorate are informed that Central Vigilance Commission has directed that the Vigilance Awareness Week be observed from **27th October to 2nd November, 2020**. Apart from creating awareness, the commission has been laying stress on the efficacy of preventive vigilance in curbing corruption. Preventive vigilance could broadly be described as a package of measures to improve systems and procedures in a way so as to reduced scope for discretion and eliminate corruption. Good governance is about the processes for making good decisions and their effective implementation. The main characteristics of good governance are transparency and accountability. Good governance and preventive vigilance share several characteristics and therefore, preventive vigilance needs to be implemented as a tool of good governance. This year the theme of observing Vigilance Awareness Week is “**Vigilant India, Prosperous India-** (सतर्क भारत समृद्ध भारत)”

The observance of the week should commence with the Pledge on 27.10.2020 and the pledge will be administered to all the Officers and Officials by the Officer-in-charge at **on 27th October, 2020**. Banners may be displayed at prominent places of the office during the week and take actions as per CVC Circular.
