Applications are invited in the prescribed format (Annexure -I) for engagement of Research Associates (RAs), Senior Research Fellow (SRF), Accountants and Laboratory Attendants (LAs), on purely temporary contractual basis in the sub-office of Directorate of Plant Protection, Quarantine & Storage, CGO Complex, NH - 4, Faridabad, Haryana, Pin - 121001 at Regional Plant Quarantine Station, Chennai from eligible candidates to be filled through walk-in interview at Regional Plant Quarantine Station, Chennai on **22nd December, 2018**. Candidates shall bring original documents along with attested photocopies of certificates from matriculation onwards, copy of recent passport size photographs and experience certificate etc. The eligibility criteria and vacant positions of RAs/SRF/Accountants/LAs are given as under.

Requirement & Eligibility Criteria:

Desirable: Having the basic and practical knowledge of HPLC, GC-ECD/FPD, GC-MS/MS, LC-MS/MS and exposure to pesticide residue analysis.
3.	Accountant	02	Bachelor Degree in Commerce (B.Com.)/ BBA Degree from recognized University/ Institute. Desirable: Experience in dealing account work, working knowledge of computer, MS Office etc.
4.	Laboratory attendant	03	10 th standard pass with five-year experience in a Chemical Laboratory in handling of chemicals and glassware.

Tenure: Initially for one year from the date of offer of appointment and the same is likely to be extended.

Desirable: Knowledge in computer applications, data organization / report writing/ IT Management.

Emoluments:

1.	Research Associate (Chemistry)	i. Rs. 40, 000/- p.m. + HRA (as per applicable rates) for Ph.D. ii. Rs. 38, 000/- p.m. + HRA (as per applicable rates) for Master Degree Holders.
2.	Senior Research Fellow (SRF)	i. For 1 st & 2 nd Year: Rs. 25,000 per month + HRA (as per applicable rates) ii. For 3 rd year onwards: Rs. 28,000 per month + HRA (as per applicable rates)

Age Limit:

- i. The upper age limit for RAs will be 40 years as on date of interview. Age relaxation of 5 years for SC/ST/Women candidates and 3 years for OBC candidates shall also be applicable as per Govt. of India/ICAR Rules.
- ii. The upper age limit for SRFs will be 35 years as on date of interview. Age relaxation of 5 years for SC/ST/Women candidates and 3 years for OBC candidates shall also be applicable as per Govt. of India/ICAR Rules.
- iii. The upper age limit for Accountant, and Laboratory attendant will be 35 years as on date of interview. Age relaxation of 5 years for SC/ST/Women candidates and 3 years for OBC candidates shall also be applicable as per Govt. of India/ICAR Rules.

Terms & Conditions:

1. The candidate must bring all original certificates along with attested photocopies of all required certificates from matriculation onwards and copy of recent passport size photographs and experience certificate in original (if any) with them which can be submitted at the time of interview.
2. Concealing of facts or canvassing in any form shall lead to disqualification or termination.
3. The engagement may be terminated at any time without notice or assigning any reason thereof. The RA/SRF/Accountant/Laboratory attendant may also leave the assignment, on their own volition, by giving one-month notice. At the end of the contracted period, the RA/SRF/Accountant/Laboratory attendant will have no right to claim any employment or engagement in the Directorate.
4. No TA/DA will be paid for appearing in interview.
5. The candidates are required to submit the applications as per the format annexed (Annexure-I).

Other Terms & Conditions

1. Candidate will not be allowed to accept or hold any other assignment during the period or his/her position as RA/SRF/Accountant/Laboratory attendant.
2. The engagement can also be terminated by the competent authority with or without notice at any time, if the appointee is found to be negligent in his/her work or is guilty of unbecoming conduct.
3. The engagement is on purely temporary basis and his/her services can be terminated within 24 hours' notice.
4. If the candidate leaves his/her assignment without permission, he/shall not be paid any salary due to him/her on that date.
5. RA/SRF/Accountant/Laboratory attendant are not transferable.
6. The Directorate holds no responsibility for his/her regularization/ absorption against any other regular post on termination of the assignment as it is purely temporary and time bound. Service of the incumbent shall stand terminated automatically on expiry of the sanction of the assignment/position.

7. The RA/SRF/Accountant/Laboratory attendant if he/she desires, may leave the assignment by giving of one-month notice and with the approval of the competent authority which he/she should deposit one-month emolument to the station.
8. The RA/SRF/Accountant/ Laboratory attendant shall settle his/her claim within three months of leaving the assignment. No claim will be entertained by the Directorate after three months of leaving/ termination of his/her services.
9. He/she will have to submit an undertaking stating that he/she will not approach Honorable Court of Law in case his/her services are terminated and not ask for any service benefit in the Directorate or request for any equivalent post in the Directorate.
10. He/she will submit a medical certificate of fitness at the time of joining from the Competent Medical Officer.
11. The research work done during the contractual period by the RA/SRF will be the property of Directorate of Plant Protection Quarantine & Storage and will have no control or right on the same. The contribution in research work can accordingly be acknowledged/ included in the research papers after the prior permission from the competent authority.
12. While leaving the job, RA/SRF/Accountant/ /Laboratory attendant has to hand over the charge to his/her Unit in-charge to which he/she is attached and obtain NOC form the competent authority.
13. Emoluments drawn by the RA/SRF/Accountant/Laboratory attendant will be subject to the Income- Tax rules applicable from time to time, if any.
14. Other conditions of Service:
 - (a) The selected candidate will be under the administrative control of Dte. of PPQ&S.
 - (b) The Selected candidates will devote his/her whole time to the assignment given to them and will not be allowed to accept or hold any other appointment paid or otherwise.
