

**MINUTES OF 341st MEETING OF REGISTRATION COMMITTEE
HELD ON 07.08.2013 IN BOARD ROOM OF ASRB, PUSA, NEW DELHI**

	The representative of M/s BASF India Ltd., Mumbai made the presentation and clarified the issues raised in 340 th Meeting with the satisfaction of the Committee. The decision in this case withheld in view of the stay order of the Hon'ble High Court of Gujarat, Ahmedabad regarding registering formulation import without registering technical.
2.3	Presentation of M/s Gharda Chemicals Ltd., Mumbai for grant of registration for indigenous manufacture of Acetamiprid 0.4% + Chlorpyrifos 20% SC u/s 9(3).

	The representative of ANA Laboratory made clarification about the test report of Alphacypermethrin Impregnated Long Lasting Mosquito Bed Net 0.55% w/w submitted along with registration application of M/s Shobika Impex Pvt. Ltd. Karur, Tamilnadu. The Committee decided that the representative of ANA Lab. should demonstrate the testing procedure/method on the remanant sample of LLIN above referred sample test report in the presence of Dr. K. K. Sharma, Project Coordinator, AINP on Pesticide Residues, Sh. R. V. Singh, Deputy Director (Chemistry), Sh. D. Bhattacharya, Deputy Director (Chemistry) at CIL, Faridabad.
3.0	Government Business
3.1	Harmonization of the data requirement as per OECD and EU guideline as recommended by Kanungo Committee Report.
	The Committee deliberated the issue and decided as under: <ul style="list-style-type: none"> i.) The finally approved/modified version of protocols for all the pre-clinical toxicity studies shall be brought in the next Meeting of RC. ii.) The Committee further decided that the desired changes may be incorporated in the Guidelines for registration of pesticides in view of the recommendations of KCR and be put in RC with in two months. iii.) The Expert working group constituted to look into the various mathematical models for spray operators exposure studies should submit the report at the earliest.

3.2	Nomination as a Co-opted Member of Registration Committee from Food Safety and Standards Authority of India, Ministry of Health & Family Welfare, New Delhi.
	In view of the communication dated 15 th July, 2013 from FSSAI, the Committee nominated Dr. Meenakshi Singh, Scientist, Standards, FSSAI, New Delhi as co-opted Member of RC in place of Dr. Dhir Singh.
3.3	Consideration of banning of Hexachlorobenzene (HCB) and Mirex as per Article 3 of the Stockholm convention.
	<p>The Committee noted the status of Hexachlorobenzene and Mirex under the Stockholm Convention and is in its commitment not to register both these chemicals as pesticides in future.</p> <p>Further, the Committee noted that these chemicals are not included in the Schedule to the Insecticides Act, 1968 and hence not registered for manufacture, import and use in the country. Therefore, these cannot be considered for ban u/s 27 (2) and/or any regulatory control under the Act.</p>
3.4	Deferment of incorporation of a cautionary statement on the label & leaflet of leaflet of pesticide formulations.
	The Committee deliberated on the matter and in view of directives from DAC, the Committee decided to defer the incorporation of caution on labels and leaflets “Not to be used on crops other than specified on this label/leaflet” pending review of guidelines on the subject and further guidance from DAC. Accordingly, a Public Notice may be issued to the above effect by the APPA & Secretary (CIB&RC) on website of the Secretariat of CIB&RC.
3.5	Consideration of the reply filed by M/s Sumitomo Chemicals India Pvt. Ltd., Mumbai (SCIPL) in response to the complaint made by All India Biotech Association (AIBA) regarding alleging illegal import of Vectobac 12 AS (B.t.i).
	<p>The Committee recalled that DAC vide its letter No. 13035/54/2012-PP.I dated March 25th, 2013 had directed it to discover true facts of the case and thereafter deliberate/discuss this matter of alleged non-compliance with the terms of registration on several counts by M/s Sumitomo Chemicals India Pvt Ltd, Mumbai (SCIPL) and communicate its opinion/view in the matter to DAC along with all relevant documents. The Committee considered the reply submitted by SCIPL with reference to the issues raised by All India Biotech Association (AIBA) and decided that SCIPL was complying with the conditions of registration of Vectobac 12 AS (B.t.i).</p> <p>The Committee noted that the product was registered for import from Valent Biosciences, USA. It involved two steps, viz.</p> <ol style="list-style-type: none"> (i) manufacture of the product in USA, and (ii) its import in the importing country. <p>Therefore, its manufacturing activity is governed by the regulations prevalent in the country of source, while its import is to be governed by the regulations in the country of import (India). The case has been examined in this perspective.</p>

	<p>USEPA, being the regulatory authority of the exporting country, has registered Vectobac 12 AS in favour of M/s Valent Biosciences Corporation, Inc vide Registration No. 73049-38 mentioning the Est. No. of its pesticide-producing site (i.e. A To Z Drying) 33762-IA-1 on the label of the product approved by it. Thus, it is evident that M/s A To Z Drying is an approved site for manufacture of Vectobac 12 AS, registered by USEPA in favour of M/s Valent Biosciences Corporation, Inc. Toll manufacturing is officially permitted in USA. To prove this fact, relevant admissible documents, issued by the regulatory authority, i.e. USEPA, have been submitted by M/s SC IPL.</p> <p>Similarly, as far as the import of the product in India is concerned, it is governed by the regulations prevalent for the time being in force, i.e. the Insecticides Act, 1968 (the Act) and the Rules framed thereunder. The Certificate of Registration was issued after due compliance of the relevant guidelines, framed by the Registration Committee (RC) and also after detailed deliberation by the Committee. The product is being imported by M/s SC IPL from M/s Valent Biosciences, USA, the source of import registered in India.</p> <p>The Committee was of the opinion that in case AIBA desires to challenge the competence of M/s A to Z Drying to Toll Manufacture the product for M/s Valent Bioscience corporation, which is permissible as per the relevant laws of the country of manufacture (USA), it can do so by challenging it before the USEPA. As long as the import of the product is from the approved source, it does not violate the conditions of the certificate of registration and, thus, does not in turn violate the provisions of the Act.</p> <p>The Committee also noted that the chemical composition of the product is registered on dry-weight basis of the active ingredient in the country of manufacture (USA), while the same is registered in India on aqueous slurry basis. The former shows the water among other ingredients. The ultimate product is an AS formulation. SC IPL have submitted a copy of the USEPA document showing that the two are equivalent. As far as labeling is concerned, the product is labeled in the US as per the label approved by USEPA, whereas the product is labeled in India as per the label approved by the RC. The directions for use, storage, etc are country-specific depending on the climatic conditions. They are approved accordingly on the labels by the respective regulatory authority.</p> <p>The Committee is also satisfied that the difference in the signatures of Mr. Alston Penfold is due to the fact that there are two persons with the same name. The difference is only in their middle name, viz. Mr. Alston Jason Penfold and Mr. Alston William Penfold. The copies of their passports have been attached by SC IPL.</p> <p>In view of above facts, Committee decided that SC IPL was/is complying with the conditions of registration of Vectobac 12 AS (B.t.i)</p>

	<p>The Committee decided to await for report of the Committee already constituted by the DAC, for this purpose under the Chairmanship of Dr. R. B. Singh, President, National Academy of Agricultural Sciences.</p>

3.7	Decision in the Appeal filed by M/s Bestnet Insect Controls Pvt. Ltd., Karur (T. N.) under section 10 of the Insecticides Act 1968 against the decision of the Registration Committee on their application for grant of registration for indigenous of <i>Deltamethrin Incorporated Long Lasting Mosquito Bed Net 0.18 w/w (65 mg.sq.m)</i> under section 9(3B)
	Noted.

	The Committee deliberated the issue and decided to incorporate the validity on the certificate of registration for formulation /technical import in cases it is mentioned by the regulatory authorities of source country at the time of verification of source by the Secretariat of CIB&RC. In such cases, the validity of registration of source should invariably be mentioned in the agenda for RC.

The Committee noted the clarification received from ICAMA wherein it is mentioned that ICAMA is a Government agency but Hunan Pesticide Association is a social group, therefore, they do not certify the content of the letter. The Committee also noted the clarification received from the applicant and Hunan Pesticide Association and ICAMA, wherein it is indicated that source actually started synthesis of this product during 2004 and received export license of the product in 2005 with license No.CHD178-2005 and got temporary registration on 8th August, 2007 and got full registration on 28th November, 2012. Further it is confirmed by ICAMA that M/s Hunan Gofar Fine Chemical Industry Tech. Co. Ltd. is a bonafide pesticide manufacturer since only manufacturer are allowed to apply for pesticide registration in China and has been granted the National Industrial Products production license on 2nd July, 2004 with the Certificate No. XK13-200-00288.</p> <p>ii.) The Committee also noted the clarifications received from the applicant regarding import of sample material for data generation and also observed that the same was/is not the requirement in guidelines and such records are not generally asked from other registrants/applicants for registration.</p> <p>In view of above and considering the fact that the application was complete from all disciplines as per the guidelines, the Committee approved the case.</p>
