

MINUTES OF 360th MEETING OF REGISTRATION COMMITTEE (RC) HELD ON 11.12.2015 IN COMMITTEE ROOM NO. 1 GROUND FLOOR, ICAR, KRISHI BHAWAN, NEW DELHI.

	The Committee noted the action taken by the Secretariat of CIB&RC and appreciated the efforts of the Sectt. of CIB&RC in completing all the follow up action in a time bound manner.

	Committee noted the progress made by the Sectt. of CIB&RC to bring the pendency from Appx. 28000 to below 500 Nos. within a period of one & a half year duration. The Chairman congratulated the Sectt. of CIB&RC for doing this wonderful job.
2.2	Presentation of M/s Rajhans Fertilizers Ltd (M/s RFL).
	<p>The Authorized Representative of M/s RFL made presentation in the Committee & made oral submissions to justify the bio-efficacy data generation gap for registration of Chlorpropham Technical for import (CIPC). After detailed scientific deliberations, the Committee decided to grant provisional registration u/s 9(3B) for a period of two years, subject to submission on revised Form-I by the applicant, as the application is complete from all the disciplines except bio-efficacy. This approval shall be subject to the following conditions:-</p> <ol style="list-style-type: none"> i. The applicant has to generate the data which has already been enumerated by the Committee in its 356th meeting of RC & conveyed to the applicant vide letter No 2145-TI/9(3)/2012-CIR-II dated 03rd August, 2015. ii. Commercialization shall be subject to approval from the DAC&FW, accordingly, a suitable communication may be sent to DAC&FW.

	<p>The Committee deliberated the agenda in detail and accepted the recommendations as proposed in the Agenda. The Committee further expressed that the new insight has been provided on subject by the Committee which seems incredible. 3.2	Consideration of recommendation of “Expert Committee” constituted under the Chairmanship of Dr. K. K. Sharma Project Coordinator, MPRNL.
	The Committee deliberated the agenda in detail and appreciated the efforts made by the committee for successful completion of recommendations on the subject. The Committee accepted the recommendations of Expert Committee as proposed in the agenda.
3.3	Consideration of the No Objection Certificates (NOCs) issued by Secretariat of CIB&RC long back for import of Insecticides without source of import, validity etc.
	The Committee deliberated the agenda in detail and observed that these NOCs have been issued by the then Secretaries of CIB&RC long back for allowing import of many pesticides/biocides etc. for non-agricultural use. Considering the fact that guidelines on the subject are under consideration, hence the Committee decided that the materials imported on the basis of these NOCs/clarifications issued from the Sectt. of CIB&RC shall be released by the Custom Authorities only after seeking clarification from the Sectt. of CIB&RC. A communication may be sent to the Custom Authorities for abiding by this decision of the Committee. The clarification shall be provided by the Sectt. of CIB&RC on case to case basis till the finalization of guidelines and/or issuance of Import Permit and further decision, if any by the Registration Committee(RC).
3.4	Views of FSSAI on the possibilities of adopting a principle of grouping crops on a scientific basis and to devise a grouping plan for different categories of crops grown in India for determination of their safe MRL’s.
	The Committee deliberated the agenda in detail and decided that the MRLs can be extrapolated in the group of crops, if the Good Agriculture Practices (GAP) are similar to the crop in the group on which MRL/risk assessment has already been done on the basis of scientific data submitted by the applicant.
