3.1	Agenda amendment in the guidelines for registration under export category with respect to Bio-pesticides / Botanicals.
	The Agenda was deliberated in details and decided that data requirement will be restricted to those parameters which are relevant to respective biopesticides as per the guidelines for their use in India. The Committee decided that no certificate of registration will be issued for export on the basis of registration of the strain of biopesticides under section 9(3B). It was further decided that the following conditions have to be incorporated in the Certificate of Registration of biopesticides for Export as well as the Certificate of Registration for Indigenous use. 1. The applicant has to obtain No Objection Certificate from National Biodiversity Authority (NBA), Ministry of Environment & Forest, Government of India before exporting of the bio-pesticides. 2. The product being exported is in compliance of Biological Diversity Act, 2002.
