This is with reference to letter no. letter No. 5-24/2017-Tech(60)/1438 dated 25.08.2022 on the above cited subject, the agency functioning without a valid stock license, since October 2017 onwards for use and stock of Methyl Bromide from State Department of Agriculture, Government of odisha and the same has been reported during renewal audit report on dated 01.07.2022 by the auditors. Hence this is an critical non conformity.

If during an audit, infrastructure & manpower of branch do not justify past fumigation activities or one or more critical non-conformities are found, fumigation company and accredited fumigation operator will be suspended and will be subject to a reinstatement audit. Re-training of accredited fumigation operator may be necessary as per NSPM-12.

In view of above, M/s. A-Pack Solutions, (604/MB), Odisha along with Fumigation Operator Mr. Aman Kumar is suspended immediately for three months due to records/documents are not found as per the provision of NSPM-12 & Insecticides Act, 1968, from the date of issue of this letter. No request of revoking will be entertained during the suspension period. After the completion of suspension period, the agency may submit a request to PQD, HQ for re-instatement audit along with justification for the corrective action taken against the Non Compliance received. Upon receipt of such request, PQD, HQ will nominate a team for re-instatement audit and for further necessary action.
