



2. On grant of financial up-gradation under the scheme, there shall be no change in the designation, classification or higher status.
3. With regard to fixation of his pay on grant of financial up-gradation under MACP Scheme, a Government servant has an option under FR22 (1) (a) (1) to get his pay fixed in the higher post/ Pay Level either from the date of his promotion/up-gradation or from the date of his next increment viz. 1st July or 1st January, subject to provisions in the Scheme.
4. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted MACPs. However, at the time of actual promotion if it happens to be in a post carrying higher-grade pay than what is available MACPs, no pay fixation would be available and only difference of grade pay/Level would be made available.
5. Respective Officer-in- charges are requested to ensure that the officials are clear from vigilance angle on the date MACP becomes effective from prospective effect.
6. The grant of above financial up-gradations under MACP is subject to review/post audit.
