3. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted MACP. However, at the time of actual promotion if it happens to be in a post carrying higher-grade pay than what is available MACP, no pay fixation would be available and only difference of grade pay/Level would be made available.

4. The grant of above financial up-gradations under MACP is subject to review/post audit if any.
