2. Under MACP Scheme the pay of the Government servant will be fixed under the rule FR 22(1)(a)(1) and other terms and conditions as modified in DoPT O.M. No. 35034/3/2008-Estt(I) dted 19-5-2009 and as amended from time to time. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted under MACPS. However, at the time of actual promotion if it happen to be in a post carrying higher grade pay than what is available under MACPS, no pay fixation would be available and only difference of grade pay would be made available.

3. The MACPS contemplates merely placement on personal basis in the immediate higher Grade Pay/grant of financial benefits only and shall not amount to actual /functional promotion of the employees concerned

4. If a regular promotion has been offered but was refused by the employee before becoming entitled to a financial upgradation, no financial upgradation shall be allowed, since an employee is not deemed to have stagnated due to lack of opportunities.
5. On grant of financial upgradation under the MACP Scheme, there shall be no change in the designation, classification or higher status. However, financial and certain other benefits which are linked to the pay drawn by an employee such as HBA, allotment of Government accommodation shall be permitted.
6. The Pay fixation in related Pay Matrix etc. should be made by respective Controlling Officers.
