

MINUTES OF 391st MEETING OF REGISTRATION COMMITTEE HELD ON 10.08.2018 IN THE ROOM NO. 138, KRISHI BHAWAN, NEW DELHI.

	The applicant presented the details relating to Bioefficacy and Toxicity data. RC noted that the Bio-efficacy data has been generated as per the then existing (old) guidelines. Applicant is required to submit data on acute mammalian studies including skin sensitization on technical compound with 92.4% a.i. min. An undertaking /documentary proof is also required to be submitted for 92.4% a.i. min indicating that it does not have any new impurity or higher concentration of impurity vis-a-vis 83.2 % a.i. Technical.

	Committee deliberated the agenda and noted that case has already been approved for grant of registration in 388 th RC meeting and decided that CR may be issued as per Form-I.
9.2	Grant of registration for indigenous manufacture of Propanil Technical 98% w/w min (TIM vs TIT) u/s 9(3) by M/s UPL Ltd.,
	Committee deliberated the agenda and noted that applicant has submitted undertaking and decided that CR may be issued.

9.3	Consideration of an application of DGHS, Ministry of Health & Family Welfare.
	Committee deliberated the agenda and noted that the label claim is approved by RC as per the data provided by the applicant. Moreover, RC also considered the fact that the data on Bioefficacy for public health are normally generated by ICMR/NVBDCP or other related institutes of Ministry of Health and Family Welfare. Hence, it was decided that the change in label claim can be considered only with a formal request from the applicants with requisite data. RC also directed Secretariat of CIB&RC to intimate to Ministry of Health and Family Welfare, accordingly.
9.4	Request for extension for the use of Synthetic pyrethroids against sand fly vector of Kala-azar under Kala-azar elimination programme.
	Committee deliberated the agenda and the request from NVBDCP was considered and approved the extension for use of Synthetic pyrethroids against Sand fly, the vector of Kala-azar under Kala-azar elimination programme for two years in view of national exigency. It was further decided that NVBDCP has to generate the required data as per the guidelines of RC for the expansion of label claim on regular basis for these insecticides against the vector of Kala-azar. No further extension will be granted as doses of synthetic pyrethroids approved for control of malaria may have risk of development of resistance in kala-azar vector (sand fly).

	Committee noted that the matter relating to grant of registration under TI category and the extension of such certificate is <i>sub-judice</i> . Accordingly, after deliberation it was decided that an affidavit from the applicant to be obtained whether the applicant possesses the certificate of registration for the product under TIM category. In case the applicant found having certificate under TIM category, the extension may be granted subject to final outcome/order in the relevant Appeal/Court Case.. RC agreed to extend the validity of the certificate of registration for import of Tolfenpyrad Technical 98.5% w/w min., if applicant found not possessing the registration for indigenous manufacture.

	Decision has already been taken in 390 th RC meeting and guidelines are already in place after approval of RC. RC noted that such guidelines will facilitate indigenous manufacture of pesticides and support the Make in India initiative.

	Committee noted that the matter relating to grant of registration under TI category and the extension of such certificate is <i>sub-judice</i> . Accordingly, after deliberation it was decided that an affidavit from the applicant to be obtained whether the applicant possesses the certificate of registration for the product under TIM category. In case the applicant found having certificate under TIM category, the extension may be granted subject to final outcome/order in the relevant Appeal/Court Case. In case the applicant is found having certificate under TIM category, the extension may be granted subject to final outcome/order in the relevant Appeal/Court Case. RC agreed to extend the validity of the certificate of registration for import of Ametryne 80% WG up to 22.01.2020, if applicant does not possess the Certificate of Registration for indigenous manufacture.

	Committee deliberated the agenda and decided that all the studies indicated in 389 th RC need to be mandatorily submitted by all the applicants for registration of new strains of <i>Paecilomyces lilacinus</i> u/s 9(3). M/s T. Stanes and Company Ltd was granted registration with the condition to submit six studies within stipulated time. ICAR IIHR have requested for grant of conditional registration as they have already deposited their strain with ICAR-NBIAM for DNA fingerprinting and long term storage. However, it was decided that their application may be considered only after submission of the studies on paecilotoxin production from a DSIR/NABL accredited government approved laboratory and intra peritoneal pathogenicity and eye irritation from a GLP accredited laboratory in support of its bio-safety.

In case the applicant possess the certificate under TIM category, the extension may be granted subject to final outcome/order in the relevant Appeal/Court Case. RC agreed to extend the validity of the certificate of registration for import of <i>Bispyribac Sodium 10% SC</i> , If applicant does not possess the registration certificate for indigenous manufacture.

	The Agenda was deliberated in detail & all the complete cases were approved as proposed in Annexure – 10.1.1 of the agenda except the products covered under the Gazette Notification SO 3951 (E) dated 08.08.2018 published on 09.08.2018. RC directed the Secretariat of CIB&RC that all the cases under section 9(4) must be issued after confirming the fixation of MRL for the product. It was also directed to recheck cases and should strictly follow Gazette Notification SO 3951 (E) dated 08.08.2018 published on 09.08.2018 of Ministry of Agriculture, Cooperation and Farmers Welfare while issuing approvals.
11.0	Any other item with the Permission of Chair.
11.1	Suspected infestation of Fall Army Worm (<i>Spodoptera frugiperda</i>) on maize in different states – Recommendation of pesticides
	<p>The matter was raised regarding the reported incidence of Fall Army Worm (FAW), <i>Spodoptera frugiperda</i> on Maize in different states. RC deliberated on the issue and advised that the pesticides recommended by ICAR and SAUs which are approved against lepidopteran pests in Maize may be used for controlling the suspected incidence of Fall Army Worm in Maize. The applications may be restricted to Maize crop only for the current season to contain the invasive pest till further notification. Necessary trials for label expansion and MRL needs to be developed as per CIB&RC guidelines within three years by the pesticide industry. Such approved pesticides are as under:</p> <ol style="list-style-type: none"> 1. Carbofuran 3% CG 2. Phorate 10% CG 3. Thiomethoxam 12.6% + Lambda cyhalothrin 9.5% ZC 4. Chlorantraniliprole 18.5% SC <p>RC also observed that there are pesticides recommended under the FAO guidelines for management of Fall Armyworm elsewhere in the world whereas such molecules are not registered in India on Maize. In view of above, RC advised that pesticides industry should come forward to submit applications for label claims of such pesticides on Maize against Fall Armyworm. Further, RC also invited suggestion from industry for temporary expansion of label claim (for current season) for any molecules if considered to be effective against FAW.</p> <p>RC further noted that the botanical pesticides like Neem (Azadirachtin), Pyrethrum and Cymbopogon have also been found effective against Fall Army Worm. Besides, the natural enemies (Parasitoids and Predators) like <i>Telenomus remus</i>, <i>Trichogramma pretiosum</i> and <i>Chelonus insularis</i> have also been reported effective in management of the pest. Besides NPV, <i>Metarhizium anisopliae</i>, <i>Entomophaga applicae</i>, <i>Nomuraea rileyi</i>, <i>Erynia radicans</i>, <i>Bacillus thuringensis</i>.</p>
11.2	RC directed Secretary (CIB&RC) to recheck cases under all categories 9(3), 9(3b), 9(4) FIM, TIM, Online, Offline, Endorsement etc and should strictly follow Gazette Notification SO 3951 (E) dated 08.08.2018 published on 09.08.2018 of Ministry of Agriculture, Cooperation and Farmers Welfare while issuing approvals. RC also directed Secretariat to close all applications which are under process pertaining to the molecules banned as per referred notification.

11.3	Status on Crop Grouping w.r.t. MRL.
	ADG (PP) reported that the work on crop grouping is completed with identification of representative crops for each group. The procedure in harmonization with international guidelines for group MRL will be presented and report will be submitted for approval of next RC.
