2. Under MACP Scheme the pay of the Government servant will be fixed under the rule 22(I)(a)(1). There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted under MACPS. However, at the time of actual promotion if it happens to be in a post carrying higher grade pay than what is available under MACPS, no pay fixation would be available and only difference of grade pay would be made available.

3. The MACPS contemplates merely placement on personal basis in the immediate higher Grade pay/grant of financial benefits only and shall not amount to actual/functional promotion of the employees concerned.

4. If a regular promotion has been offered but was refused by the employee before becoming entitled to a financial up-gradation, no financial up-gradation shall be allowed as such an employee has not been stagnated due to lack of opportunities.

5. On grant of financial up-gradation under the Scheme, there shall be no change in the designation, classification or higher status. However, financial and certain other

benefits which are linked to the pay drawn by an employee such as HBA, allotment of Government accommodation shall be permitted. The post/grade pay either from the date of his/her promotion/up-gradation or from the date of his/her next increment viz. 1st January & 1st July of the year.

6. Respective Officer-in-charges are requested to ensure that the officials are clear from Vigilance angel on the date of MACP becomes effective from prospective effect.

7. The grant of above financial up-gradations under MACP is subject to review/post audit.
