Vide this Dte's Office Order No.- 77 of 2023 dt. 06.05.2023 Sh. O.B. Likhar, Assistant was adjusted against the vacant post of APPO. Now, as per vacant post in this directorate & with the approval of the competent authority, his posting is treated against the vacant post of Assistant (GCS).

- 2. Since the above transfers/postings are in public interest the officials will be entitled to TTA and joining time etc. as admissible under the Rules.
- 3. The concerned officers-in-charge are requested to relieve the officials under their control. They are advised to join the post of Assistant (GCS) at the stations indicated against their names latest by 26<sup>th</sup> July, 2024, otherwise it will be presumed that they have refused the promotion and accordingly they will be debarred from promotion to the post of Assistant (GCS Cadre) as per rules.
