2. These safaiwala will not be engaged for full time and will be engaged only for two/three hours daily/need basis, through an agency and at minimum wage as per rates of the labours Department of that state.
3. He / She will not claim for regular appointment. An affidavit to this effect will be furnished by the safaiwala before engaging him/her that he/ she will not be entitled for regular appointment.
4. The Directorate is facing litigation from some of the part-time safaiwala /part time labours for their regularization in Government Service as they have been engaged by the Sub- Offices for a very long time. To avoid such litigations the Officer-in-Charge of the Sub-Offices are, therefore, requested not to engage same person on part-time safaiwala/ labours for more than three months continuously in financial year.
