PUBLIC NOTICE

Subject: Non-compliance of rules and regulations by Chinese manufacturer registered as import source of *Dimethoate technical* in India. -reg.

Reference is invited to the decision taken by the Registration Committee (RC) in its 453^{rd} meeting held on 16.01.2024 vide Agenda Item No. 10.3. The decision of the RC is reproduced below :

"RC deliberated the agenda and based on the facts presented to the RC, observed that for the source of Dimethoate Technical, M/s Chongging Chemical Pesticide (Group) Co. Ltd., only endorsement for change in name of the company was obtained and intentionally not informed CIB&RC about the change in the location of the manufacturing site. The confirmation from ICAMA about change in manufacturing site by this company is on record. RC further noted that the rules framed in 325th RC meeting, in case of the change of location of the manufacturing site of the source of import, clearly mandate to submit 5-Batch samples of the product manufactured at old and new manufacturing sites, which are to be tested at CIL for verification and ensuring no change in the impurity profile. In this case no such procedure was adopted and CIL could not test the samples. Now, after expiry of more than 10 years, it is not possible to have samples from old plant today, as it has been dismantled. Thus, the process cannot be completed on date. Any applicant requesting import source of Dimethoate Technical from M/s Chongging Chemical Pesticide (Group) Co. Ltd., may be considered as a new registration requiring submission of data as required.

Hence, the RC decided to cancel the captioned import source of Dimethoate Technical, namely M/s Chongqing Chemical Pesticide (Group) Co. Ltd., with immediate effect and directed the Secretariat to intimate the concerned stakeholders to this effect along with the customs authorities for intimating the field formations at all the entry points. A public notice to this effect be issued immediately."

- 2. Accordingly, the above decision of the RC is published to the concerned stakeholders and Customs Authorities for further necessary action and compliance.
- 3. This has the approval of Secretary (CIB&RC).
