PUBLIC NOTICE

Subject: Public notice regarding approval of application of M/s FMC India Pvt. Ltd., for endorsement of change of name of source of import on the certificate of registration of Chlorantraniliprole Technical 93% w/w min. U/s 9(3) TI -reg.

The Registration Committee in its 449th meeting held on 26.07.2023 vide Agenda Item No. 9.55 while considering an application of M/s FMC India Pvt. Ltd., for endorsement of change of name of source of import due to disinvestment of Chlorantraniliprole Technical 93% w/w min. U/s 9(3) TI has decided as under:

"RC deliberated the agenda and approved for endorsement in the change of name of source of import on the registration certificate Chlorantraniliprole Technical 93% w/w min. u/s 9(3) TI vide F.No. 6- TI/9(3)/2007-CIR-II and registration No. CIR-878/2008(292)- Chlorantraniliprole (T)-01 M/s DuPont Agricultural Chemicals Ltd., to M/s FMC (Shanghai) Agricultural Sciences Co. Ltd., The applicant has applied for the purity enhancement as 95.3% Purity vide application number EN-44287 & the both cases taken simultaneously in the 449th RC meeting.

Certificate of Registration (CR) of the same shall be issued only subject to submission of Original (Hard Copy) Affidavit & ICAMA/Apostle, letter of consent whichever is applicable.

RC decided that a public notice shall be issued giving ten days' time from the date of application of the notice to the stakeholders for comments on this change."
