

BRIEF DESCRIPTION OF DUTIES

Head Quarter, Directorate of Plant Protection, Quarantine & Storage, 1st Floor, Block-III, CGO Complex, NH-IV, Faridabad along with PQ stations

The ongoing activities assigned under the scheme include:

- To issue import permits with additional declarations and special conditions to facilitate safe imports of agricultural products.
- To undertake quarantine inspection and laboratory testing of plants and plant material to ensure freedom from exotic pests.
- To undertake phytosanitary certification (for issuance of Phytosanitary Certificates (PSCs);
 201 Nos. of Officers from Central/ State/ UT Governments have been authorized for this purpose.
- To undertake fumigation/disinfestations/disinfections of commodities to control infestation/infection.
- To undertake certification of post-entry quarantine facilities and inspection of imported growing plants and plant material; 45 Nos. of Inspection Authorities have been designated.
- To support Export market access for India's Agriculture products from the phytosanitary point of view.
- To facilitate safe global trade in agriculture by assisting the producers and exporters by providing a technically competent and reliable phytosanitary certificate system to meet the requirements of trading partners.
- To provide Grants-in-aid to Designated Inspection Authorities to meet the travel expenses and also to State PSC issuing authorities for equipping them with minimal equipments required for export inspection/certification.
- Granting approval/accreditation of Treatment providers in line with the requirement of ISPM-15.
- To undertake PRAs of different agricultural commodities with respect to their import or export in relation to the countries concerned.

BRIEF NOTE ON PLANT QUARANTINE

Plant Quarantine (PQ) regulatory measures in India are operated under -"Destructive Insects & Pests Act, 1914" & "PQ Order, 2003"

Objectives...

- ➤ Prevent introduction and spread of exotic pests that are harmful to crops by regulating/restricting import of plants/plant products.
- > Support market access for India's agriculture products.
- Facilitate safe global trade in agriculture by providing producers and exporters, a technically competent and reliable Phytosanitary certification system, to meet requirements of trading partners.

Import-Regulations

- ➤ The import of plants and plant materials are covered under the Plant Quarantine (Regulation of Import into India) Order, 2003 issued under the Section 3 (1) of DIP Act, 1914 and amendments issued there under from time to time.
- ➤ PQ Order, 2003 effective from1.1.2004replaces the Plants, Fruits and Seeds (PFS) Order, 1989and Cotton Regulations, 1972 and other previous orders.

Import-PQ Order, 2003

- Points of Entry are notified vide Schedule-I,II&III
- Seeds and Propogative plant material can only be imported through six major ports viz., Amritsar, Chennai, Kolkata, Mumbai, New Delhi and Bangalore
- Commodities for consumption can be imported through all the notified ports
- Commodities prohibited are notified in Schedule-IV
- Commodities restricted to enter are notified in Schedule-V
- Commodities regulated to import with additional declarations and special conditions are covered in Schedule–
- Commodities of least risk category for consumption purpose are specified in Schedule-VII. PSC is must for the commodities covered in Schedule - VII.
- The 57 Quarantine weeds are notified in Schedule-VIII
- Import Inspection fee and treatment fee are stipulated in Schedule-IX

Phytosanitary Certification

- ✓ Export certification is carried out in accordance with the provision of Article V of IPPC.
- ✓ The export inspection is conducted as per the Standard Operating Procedures for Export Inspection and Phytosanitary Certification and also in line with the relevant International Standards:
- ✓ ISPM7-Export Certification System
- ✓ ISPM12-Guidelines for Phytosanitary Certificates
- ✓ ISPM23-GuidelinesforInspection
- ✓ Twenty three National Standards for Phytosanitary Measures (NSPM) has been developed.
- ✓ 197 PSC issuing authorities notified.
- ✓ Plant Quarantine online web portal had been upgraded and launched as Plant Quarantine Management System (PQMS) w.e.f. 18th April, 2022
- ✓ Noncompliance module launched in PQMS portal w.e.f. 05.12.2023.
- ✓ Integration of Grapenet of APEDA with PQMS Portal w.e.f. 01.03.2023.
- ✓ Launch of NSPM-23 in PQMS Portal w.e.f. 01.05.2023
- ✓ PQMS had been integrated with IPPC's e-Phyto w.e.f. 01st March, 2023.
- ✓ PQMS Mobile App with Geo tagging has been launched w.e.f. 20th September, 2022 for conducting import and export phytosanitary inspections.

Global–Participation (International Obligations)

- ✓ Food and Agriculture Organization (FAO): India is one of the founding members of FAO of United Nations FAO since 1945 & DPPQ&S actively engaged in relevant deliberations.
- ✓ **International Plant Protection Convention (IPPC):** The IPPC is governed by the Commission on Phytosanitary Measures (CPM), which was established under Article XII of the New Revised Text of the IPPC, approved in1997, and serves as the Convention's governing body. India is one of the contracting parties of IPPC (Total 183 parties).
- ✓ **CODEXALIMENTARIUS:** *Codex Alimentarius* **Commission**, a body that was established in early November 1961 by the FAO and WHO. DPPQ&S actively engaged in relevant tasks.
- ✓ **Rotterdam Convention:** Signatory Nations can decide whether to allow or ban the importation of chemicals listed in the treaty, and exporting countries are obliged to make sure that producers within their jurisdiction comply. DPPQ&S play important role in relevant tasks.
- ✓ Montreal Protocol: The Montreal Protocol on Substances that Deplete the Ozone Layer, 46 countries are member and India is one of them. DPPQ&S always compliance the guidelines framed by Montreal Protocol.
- ✓ World Trade Organization (WTO): The WTO officially commenced on 1 January 1995 under the Marrakesh Agreement, signed by 123 nations on 15 April 1994, replacing the General Agreement on Tariffs and Trade (GATT), which commenced in 1948. India is member country and DPPQ&S play important role in trade related issues.
